

### **GENERAL ADVOCACY DIALOGUES, ACTIVITIES AND EVENTS**



On 17 February 2022, EABC joined JFCCT for a courtesy visit to the His Excellency General Prayut Chan-o-cha, Prime Minister of Thailand. The European Chamber of Commerce in Thailand was represented by its Vice-President, Mr. Bob Fox, for this meeting during which the Prime Minister spoke on Thailand 4.0, Digital transformation, Economic Development, Sustainability and Green economy, BCG economy and ESG.



On 22 February 2022, the EABC had the opportunity to discuss with the ESF (European Services Forum) about services in Thailand and possible collaborations. The key topics that were covered included.

Thailand's regulatory framework in services sector, service liberalization, trade in services and EU-Thailand FTA. The discussion was informative and uncovered many possibilities in the future to propel Thailand's economy forward.



On 24 February 2022, EABC Board of Directors met with the Ambassador of the European Union to Thailand and the Trade Department of the EUD, to discuss opportunities for a deeper collaboration on EABC's advocacy activities in the coming year.

The meeting included a presentation of EABC's Working Groups, including our new foray for the Cross Sectoral Issues WG into Sustainability, of our 2022 European Business Position Paper and to new areas of cooperation. The expected EU-Thailand Free Trade Agreement and recent developments of a Directive on corporate sustainability due diligence by the European Commission.



On 31 May 2022, Mr. Jan Eriksson, Mr. Bob Fox, Mr. Paul Scales (Irish Chamber), Mr. Anthony Hoglund, and Dr. Charanya Nopnukulvised, representing the EABC and JFCCT, met with Mr. Thosapone Dansuputra, Director-General Department of Business Development, Mr. Worwait Sing-In, Director of Foreign Business Administration Division, Ms. Punthip Chunsiripong, Trade Officer and Senior Professional Level of Foreign Business Administration Division and Mr. Somatat Sangkomkamhang, Trade Officer to discuss decision-making processes for Foreign Business Act List 3 and select substantive areas in List 3.



On 2 June 2022, EABC hosted a meeting with the European Union Delegation (EUD) along with other EU Member States (Embassy of France, Embassy of Spain, Embassy of Netherlands, Embassy of Portugal, Embassy of Belgium, Embassy of Greece, Embassy of Czech Republic, Advantage Austria and Embassy of Germany) on the developments of the EABC Food and Beverages Working group.

Constructive discussion during the meetings covered various key topics within the food, beverages and agricultural sector. The EUD and other EU member states provided positive support to the Working Group and gave an insight to the key areas where EABC could advocate for, to create an improve business environment in Thailand.



On 8 June 2022, Mr. Guillaume Rebiere, then Executive Director of EABC attended meetings arranged by DG Grow in Brussels, and included a meeting with Dominic Alexander Boucsein, Head of International Trade and Foreign Policy at EUROCHAMBRES. The discussion covered the business environment in Thailand, a follow up on EU-Thailand economic relations, and potential future collaboration between EABC and Eurochambres.



On 8 June 2022, Mr. Guillaume Rebiere, former Executive Director of EABC attended the annual European Business Organisation (EBO) network meeting in Brussels. This meeting was intendecc to allow Eurochams as EBOWWN members from all around the world to exchange ideas, good practices and experience, and discuss stronger

cooperation within the network in the future. It was also the occasion to re-engage with European institutions, Directorates General, and other European stakeholders after two years of pandemic.



On 30 August 2022, Mr. Bob Fox, EABC Board Member and Chair of Digital Economy/ICT Working Group spoke, along with other European private sector representatives in Thailand at a seminar on "Keeping Pace with the EU's New Trade Policy and Rules" organised by Department of Trade Negotiations (Ministry of Commerce) at Peninsula Bangkok.

The EU's trade-related regulation, including Due Diligence (covering human rights and environment), deforestation-free products, eco-design for sustainable products (circular economy principles), new rules on single-use plastics, European Green Deal (including climate change and CBAM) are generally referred to as being about 'sustainability'. Also covered were services liberalisation and procurement.

Many are domestic EU policies either with a potential international trade and investment impact, or which have extra-territorial reach.

They would, once fully enacted, have their own effect and force and in addition would be put forward as part of a future Thailand-EU FTA.

Mr. Bob Fox shared EABCs perspectives and recommendations, together with Mr. Tom Cachet and Dr. Ajaree Tavornmas from TEBA, Dr. Nilsuwan Leelarasamee from The Federation of Thai Industries & The Subcommittee on Trade Regulations and Multilateralism, Dr. Chanintr Chalisarapong from Board of Trade of Thailand & Thai Tuna Industry Association, Dr. Thitiwut Srimanop from The Federation of Thai SME.

Business in Thailand, whether local or European, have shown general support for the new polices as they are considered to move economies and societies in positive (often essential) directions. Issues such as additional administrative overhead, competitiveness, ease of doing business are unavoidably relevant. How the policies can be implemented and supported was part of the

EABC provided, earlier in 2022, a response as part of the EU's public consultation on Due Diligence, with such a balanced approach. EABC's 2022 European Business Position Paper in its Introduction Chapter (and in its CSI and Energy chapters) provides background.

A Partnership and Co-Operation Agreement (PCA) was eventually signed on 14 December 2022, aimed at closer economic and political ties with Thailand, and resuming trade negotiations for an FTA".





On 26th August 2022, EABC delegates led by Ms. Khemika Ratanakul, Vice chair of IPR Working Group and Ms. Warangkana Hicks, Policy Manager attended The 2022 Intellectual Property Rights Infringing Goods Destruction Ceremony organized by Department of Intellectual property and states agencies.

The opening remarks presided by Mr. Vuttikrai Leewiraphan, Director General of the Department of Intellectual Property and Mr. Sinit Lertkrai, Deputy Minister of Commerce at the Antiaircraft Artillery Regiment, Don Mueng.

On 31 August, 2022, EABC led by Mr. Jan Eriksson, Vice President and with Mr. Bob Fox, Board member and Chair of Digital Economy / ICT Working Group, and Ms. Warangkana Hicks, Policy Manager of EABC attended the Long-Term Resident Visa (LTR) Launching Event organized by Thailand Board of Investment (BOI) at Waldorf Astoria Bangkok.

The LTR scheme has four categories each with its own target groups and requirements and aims to appeal to foreigners (whether abroad or here in Thailand) to contribute variously to investment, domestic spending, skills transfer and imparting knowledge. There are many privileges for LTR visa holders which should make living in Thailand more attractive and less bureaucratic.

The LTR scheme does not include a 'digital nomad' visa and is not a sinecure for all work permit and visa issues It is for specific groups each with a wealthier profile. EABC, with collaborators, has been involved in the development of the Smart Visa and now the LTR visa for some years.

LTR Visas were open for application from September 1, 2022. The visa (typically 5+5 years) comes with an 'automatic' digital work permit where needed. Post event update: the Highly Skilled cateogory was expanded considerably 16 March 2023.



On 7 September 2022, EABC President, Mr. Farid Bidgoli, and some members of the Board of EABC, had a constructive meeting with H.E. Mr. Daly, Ambassador of the European Union to Thailand, and with members of the European Union Delegation. The discussion aimed to identify areas related to European policies, on which our two organisations could cooperate even more in the future. It was a very productive exchange, and will lead to new potential projects for EABC's Working Groups.



On 14th September, EABC delegates led by Khun Warangkana Hicks, Policy Manager of EABC and Khun Christian Mehlhorn, Digital Service Manager Asia/Pacific at Siemens Mobility attended the Opening Ceremony of ASEAN Sustainable Energy Week and Electric Vehicle Asia 2022.

The opening remarks presided by Prof. Dr. Pisut Painmanakul, Representative of the Minister of Energy with Keynote Address on "Thailand Energy Transition Plan Towards Carbon Neutrality" at Queen Sirikit National Convention Center (QSNCC).

ASEAN Sustainable Energy Week & Electric Vehicle Asia 2022 organized by Informa Market. It is ASEAN's Most Comprehensive International Exhibition and Conference on Renewable Energy, Efficiency, Energy Environmental Electric and Vehicle Technology. The event is co-located with Boilex Asia & Pumps and Valves Asia 2022-The Region's Leading Exhibition Specializing in Boiler, Pressure Vessel Pumps and Valves Technology.



On 16 September 2022 - Ms. Khemika Ratanakul, Chair of F&B Working Group and Vice Chair of IPR Working Group, Ms. Warangkana Hicks, Policy Manager of EABC and Mr. Chet Suksang, Trade and Economic Officer from EU delegation attended Thai Customs IPR Recordation Systems (TCIRs) event at the Customs Department.

TCIRs event was aimed to practice the understanding of the submission of trademark and copyright information request through the Customs department's trademark and copyright database system. The opening remarks presided by Mr. Pongthep Buasub, Deputy Director-General of the Customs Department.



On 23 September 2022, EABC held a meeting with Mr. Lavaron Sangsnit, Director General of Revenue Department. We also took this opportunity to congratulate Mr. Lavaron Sangsnit on his new role as the Director General of Revenue Department and to present a print copy of EABC's 2022 European Business Position Paper to his team.

EABC would like to extends thanks to his team for constructive discussions on various tax topics; e-commerce tax, digitalization of tax compliance, cross border-date and financial flows, BEPS plans and tax incentives to attract skilled workers.





On 11 October 2022, EABC delegates led by Mr. Jan Eriksson, Vice President, Mr. Bob Fox, EABC Board Member and Chair of Digital Economy/ICT Working Group and Dr. Charanya Nopnukulvised, Operations Director attended the 5th edition of the Sustainability for Business Forum 2022: Technology as Enabler organised by Franco-Thai Chamber of Commerce (FTCC), Netherlands-Thai Chamber of Commerce (NTCC) and Thai-Swedish Chamber of Commerce at Marriott Marguis Queen's Park. The opening remarks presided by Mr. Pornphrom Vikitsreth, Advisor to Governor of Bangkok (Environment Affairs). Mr. Bob Fox also was moderator of two Track #3 Sustainable sessions on Digitalisation and CEO Panel.

On 25 October 2022, EABC Chair of Rail and Road Infrastructure, Mr. Georg Wolff, attended the lunch talk with Bangkok Governor, Mr. Chadchart Sittipunt, organized by the Franco-Thai Chamber of Commerce (FTCC) at SO/Bangkok.

Governor Chadchart outlined his vision to develop Bangkok as "a livable city for all" as well as his development plans on education, healthcare, environment including infrastructure. Mr. Georg Wolff also had an opportunity to hand him a copy of the 2022 EABC Position Paper.



On 28 October 2022, EABC signed the MoU on Online Advertising and IPR at the Office of the Permanent Secretary, Ministry of Commerce. The Signing Ceremony was witnessed by Mr. Sinit Lertkrai, Deputy Minister of Commerce. A representative from EABC, Ms. Khemika Ratanakul, Chair of F&B Working Group and Vice Chair of IPR Working Group, attended and signed the MoU together with the Department of Intellectual Property, Advertising Association, the Owner of Intellectual Property Rights and the representatives from public and private sectors.

The MOU is an important milestone for IPR development, which will be beneficial to the advertising industry, IP owners, e-commerce including digital content.. This is the second of two MoUs, the first being about on-line activity generally.



#### **EABC WORKING GROUPS**

#### **CROSS SECTORAL ISSUES (CSI)**

Sustainability integration is a planned mission for all EABC Working Groups. The formal establishment of a Sustainability Cluster in EABCs Cross Sectoral Issues (horizontal) Working Group shows a central focus for this horizontal engagement. The objective for the sustainability cluster is to build upon leading global norms (with important leading European policy) and also Thailand's adoption of the BCG and Net Zero Climate commitments, environmental and other commitments through advocacy engagements and education, to ensure that trade and foreign business development in Thailand are progressing in an environmentally and socially sustainable manner. The Working Group has developed a knowledge base in ESG standards and reporting.

#### **DIGITAL ECONOMY/ICT**



On 24 January 2022, the EABC-JFCCT Digital Economy and ICT Working Group Meeting with Flg.Off. Somporn Pandam Deputy Secretary-General of Vocational Education Commission was held virtually.

It has been EABC's long-termed goal to support the realization of the Thailand 4.0 vision towards a competitive economy through upskilling and re-skilling. EABC Digital Economy and ICT Working Group has been engaged with the digitalization of the economy and business lives including the promotion of education and skills development to support the digital sectors.

Flg.Off. Somporn Pandam kindly provided us with meaningful answers during the Q&A session. The *questions* were mainly about the current status of the three apparatus - the Human Capital Excellence Center (HCEC), the Digital Education Excellence Platform (DEEP) and the Excellence Individual Development Plan (EIDP) well the as issues as

regarding Thailand Education Eco-System (TE2S) initiative and digital literacy.



On 28 June 2022 – The EABC and JFCCT Digital Economy and ICT Working Group led by Mr. Bob Fox had a meeting with Dr. Sak Segkhoonthod, Deputy Executive Director of ETDA and his team regarding the topic of Digital Transformation, Electronic Signatures, National ID, Digital skills and others related issues.



EABC Digital Economy/ICT Working Group Chair and Board member, Mr. Bob Fox, chaired and was moderator of the central session on Digital Culture of Enterprise Digital Transformation Asia Conference 2022 organised by Escom Events was held on 3-4 August 2022. Panellists were Mr. Ajay Wadhwa, Head Global Business Services at Indorama Ventures PCL, Mr. Dan Ramirez, Business Excellence Head at Insular, and Mr. Fadly Rasyad, Enterprise Agile Coach at Bank of Singapore. Mr. Bob Fox shared his

perspectives on the importance of Digital Values & Culture including identifying them, inculcating them and using them for successful transformations and 'being digital' in an on-going way.



On 20 September 2022, EABC Digital Economy / ICT Working Group organised a Site Visit of SUPERNAP Thailand at Chonburi. The Site Visit included a presentation of SUPERNAP (Thailand) and their services, followed by a tour of SUPERNAP (Thailand) Data Center, and concluded by an exclusive networking event at the Pattana Golf Club. We appreciate the support and active participation of the members of our Digital Economy / ICT Working Group, and we will continue to be the leading voice for the European business community in this sector.

The Digital Economy/ICT Working Group engages in many policy and law developments, through dialogue, public hearings and written submissions. These cover Data Privacy, Digital Signatures, Digital payments, Digital Platforms, Innovation and Tech Start Ups, Work Permit & Visa (including LTR and Smart Visa).

#### **ENERGY**

Thailand Climate Action Conference (TCAC) aims to enhance Thailand to move towards low greenhouse gas emission and climate resilient development that align with the UNFCCC and the 2030 SDGs.

#### **HEALTHCARE AND PHARMACEUTICALS**

The meeting touched upon a number of topics with a review of existing E-Pharmacy systems in both the Western and Eastern countries, their differences and similarities. The meeting uncovered key information about the necessary infrastructure needed to develop an E-Pharmacy eco-system in Thailand.



On 8 April 2022, EABC together with the EU-ASEAN Business Council (EU-ABC) and Chulalongkorn Faculty of Pharmaceutical Sciences hosted the webinar on Moving forward on the self-care path in digital new normalcy. This webinar focused experience sharing about self-care according to international experiences as well as deep diving to economic impact of self-medication in Thailand from an academic viewpoint. We had the honour to welcome H.E. Mr. Statit Pitutecha, Deputy Minister of Public Health to open the event and kindly summarised the current position of Self-care in Thailand and future possibilities within the sector.



On 30 June 2022 – The EABC Health and Pharmaceuticals Working Group led by Ms. Paranee Adulyapichet had an in-person meeting with Mr. Sittichai Ngamkiatkajorn, Director of Medical Benefits Division of the Controller General's Department at the Ministry of Finance.

#### **INTELLECTUAL PROPERTY RIGHTS (IPR)**



On 6 May 2022, EABC and the South-East Asia IP SME Helpdesk co-organised the "Virtual Training: Online Enforcement of Intellectual Property Rights in Thailand". The event was a huge success with great contributions from two experts in the IP sector, Ms. Kannicha Wungmuthitakul (Tilleke & Gibbins) and Ms. Raenuka Fangthong (Lazada) who provided industry on the insight current regulatory developments of Online IP infringements and real-world implementations of the enforcement from one of Asia's largest ecommerce platform.



On 24 May 2022, EABC had an opportunity to meet with Khun Kanitha Kungsawanich, Deputy Director General, along with other representatives from the International Affairs Office, Legal Affairs Office, and Bilateral Cooperation section of the Department of Intellectual property (Ministry of Commerce).

The meeting was led from the EABC side by active IPR Working Group members, Mr Bob Fox (with a deep involvement in Copyright and Ms Paranee Adulapichet (with a deep involvement in Patents)

The meeting was set up under the umbrella of EABC's Working Group on Intellectual Property Rights. Constructive discussions during the meeting allowed to cover various topics surrounding the current developments of IP in Thailand including; Patent Act, MoU on Online advertising, Draft Customs Notification, IP and Ransomware and Post COVID-19 IΡ Challenges.



On 22 July 2022, EABC and the South-East Asia IP SME Helpdesk co-organised "EABC and South-East Asia IP SME HELPDESK Webinar on "How to make IPR protection easier for business in Thailand." The event was a huge success with great contributions from our panelists with informative insights on the importance of protection of IPRs in Thailand in light of current and future IP legislative framework, the enforcement of IPR and how IPR holders can effectively combat counterfeiting offline and online, and the commercialization of IP assets.



On 6 September 2022, Department of Intellectual Property held a meeting on 'Stakeholders Consultation on the Protection and Enforcement of IPRs in Thailand' Zoom. via Mr. Vuttikrai Lewiraphan, Director General of DIP presided the opening remarks and welcomed all the participants in the meeting.

EABC led by Mr. Franck Fougere, Chair of IPR Working Group, Ms. Khemika Ratanakul, Vice Chair of IPR Working Group, and Mr. Bob Fox, EABC Board Member and Chair of Digital Economy/ICT Working Group had the opportunity to share perspectives on various topics; Patent Act, Copyright Act, Online enforcement, MoU on Online Advertising and Intellectual Property Right, Ransomware and Trademark Act. The meeting was also ioined by representatives from EU Delegation to Thailand, US Embassy, USPTO, EU-ABC, and AMCHAM.



On 24 November 2022 - Ms. Khemika Ratanakul Chair of Food & Beverages Working Group moderated a Roundtable Discussion & Open Forum on the New Customs Notification System: Issues, Challenges, and Opportunities at the Workshop on the New Customs Notification System on Border Enforcement of Trade Marks and Copyrights in Thailand organised by IPKEY SEA.

Following the issuance of Customs Notification No. 106-2565 in relation to the Export, Import, and Transit of Trademarkand Copyright- Infringing Goods, the workshop aimed to promote awareness and better understanding of the practical implications of the new customs notification system for EU businesses and brand owners in Thailand.
