# Responsible Business Roundtable: An interactive discussion on the challenges faced by companies

This session provides an opportunity for companies and other private sector actors to discuss challenges and opportunities in a closed-door setting, facilitated by UNDP

#### **Background**

Unanimously endorsed by the UN Human Rights Council in 2011, the United Nations Guiding Principles on Business and Human Rights (UNGPs) provide a globally authoritative framework on how businesses can respect human rights. In little less than a decade, the UNGPs have spurred the development of policies and laws to address adverse business-related human rights impacts, including mandatory human rights and environmental due diligence laws, modern slavery acts, import bans for goods produced with forced labour, and corporate sustainability disclosure requirements, among numerous others.

Accordingly, companies are presented with a number of challenges including the need to engage company stakeholders and protect individuals and communities who may be negatively affected by business operations, including through human rights policies, human rights due diligence processes, and grievance and remediation mechanisms.

UNDP <u>B+HR Asia</u> Programme has been working in close coordination with government, business, civil society, academia and multilateral actors to promote the implementation of the UNGPs in Asia since 2016. In addition to regional activities such as UN Responsible Business and Human Rights Forums, UNDP works in 12 countries in Asia to promote business respect for human rights.

In this context, UNDP is organizing the **Responsible Business Roundtable: An interactive discussion on the challenges faced by companies**. The roundtable is open to all private sector representatives and aims to create a space where companies can discuss challenges and potential solutions in promoting greater business respect for human rights throughout their operations and value chains. The session will also inform UNDP programming on business and human rights in Asia.

#### About the session

The roundtable session will facilitate internal discussion among companies and other private sector actors to discuss their human rights-related challenges in a closed-door setting. Participants will be encouraged to reflect on the **challenges** companies face in respecting human rights in their own operations and across their supply and/or value chains, as well as on the **solutions** which industry peers have used to address such challenges. The discussion may focus on, for example:

• Responding to changing expectations from business relationships, regulators, consumers, investors, and society at large;























- Developing and enforcing corporate human rights policies and related instruments such as internal and business relationship-oriented codes of conduct;
- Identifying, addressing and reporting on human rights (i.e., human rights due diligence);
- Exercising leverage over business relationships, both upstream and downstream;
- Establishing and operating grievance mechanisms; and
- Consulting and engaging stakeholders, especially affected individuals and communities.

The session is free of charge and open for registrants of the 2023 UN Responsible Business and Human Rights Forum.

#### **Objectives**

The roundtable discussion will serve as a platform to:

- Gain new ideas on how companies can respond to emerging expectations from regulators, investors and civil society actors;
- Discuss challenges and solutions to common human rights challenges faced by companies; and
- Network with and learn from industry peers.

In addition, the session will inform UNDP programming on business and human rights in Asia.
