**Meetings** – for a long time there were seemingly petty restrictions with no overseas participation, 1/3 having to be one place and cumbersome technical requirements; the crisis forced an elegant solution in April by a Decree, but possibly with some baggage with security overhead. Mandatory for all meeting types required to be held.

**eSignatures** - but we love our wet signatures and hard copy paper – legally enabled since 2001, but why the slow take up? What is behind this and what can be done?
